4. There are no costs ordered in respect to any steps taken in this action.



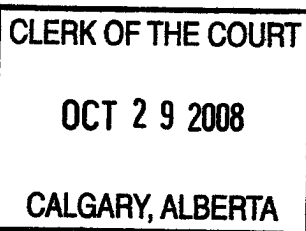
